#### ORDER ROC.NO.5326/2013-B.SPL. DATED:21.09.2013.

On the recommendation made by the High Court, the Government in their  $G.Os.\ 1^{st}$  to  $4^{th}$  read above issued orders approving the names of **42** (1+2+5+34) candidates as Junior Civil Judges. The High Court while communicating the said orders to the Candidates directed them to submit their Physical Fitness Certificates on or before 10.09.2013. In turn, all the candidates have submitted their Physical Fitness Certificates.

As per Rule 8 of Andhra Pradesh State Judicial Service Rules, 2007 every person who is appointed to the category of Civil Judges (Junior Division) shall under go training in the Academy, for a period one year.

The Director, Andhra Pradesh Judicial Academy, Secunderabad in his letter 6<sup>th</sup> read above, informed the Hon'ble High Court, that the Hon'ble Board of Governors of Andhra Pradesh Judicial Academy, Secunderabad, accorded permission to commence the XIX Basic Course for 42 candidates for a period of six months i.e., Part-I Institutional Training for a period of five months from 01.10.2013 to 28.02.2014 and Part-II Mid Term Practical Training for a period of one month from 01.03.2014 to 31.03.2014 at Andhra Pradesh Judicial Academy, Secunderabad.

In view of the above, the High Court is pleased to pass the following order:

All the 42 newly selected Junior Civil Judges (list enclosed) in the  $G.Os.1^{\rm st}$  to  $4^{\rm th}$  read above are hereby directed to report before the Director, Andhra Pradesh Judicial Academy, Sardar Pattel Road, Secunderabad at 8.00 a.m. on

01.10.2013 for undergoing XIX Basic Course for a period of six months i.e., Part-I Institutional Training for a period of five months from 01.10.2013 to 28.02.2014 and Part-II Mid Term Practical Training for a period of one month from 01.03.2014.

The trainee Junior Civil Judges will be under the control of the Director, Andhra Pradesh Judicial Academy, Secunderabad during the period of their training.

The Director will collect the Statement of Properties and Relations, oath forms and joining reports in respect of 42 Candidates and send the same to the High Court.

At the end of six months training, the Director should submit the report to the High Court with reference to each trainee officer regarding successful completion of XIX Basic Course.
