# COMPETITIVE EXAMINATION FOR DIRECT APPOINTMENT TO PUNJAB SUPERIOR JUDICIAL SERVICE – 2019

Applications are invited for filling up of 8 vacancies for appointment to Punjab Superior Judicial Service by way of direct recruitment from amongst the eligible Advocates through competitive examination under Rule 7(3)(c) of Punjab Superior Judicial Service Rules, 2007 in the prescribed Application Format (Annexure-1 page 8-9), in the pay-scale of ₹51,550-1,230-58,930-1,380-63,070 + allowances as admissible under the Rules. The High Court of Punjab and Haryana, Chandigarh reserves the right to alter (on either side) the number of vacancies notified.

Last date for submission of applications and eligibility in all respects for the candidates shall be 31.07.2019.

The posts reserved for General (Sports Persons) and S.C. (Sports Persons) (both being advertised for the 3<sup>rd</sup> time), shall be filled in from Open Category candidates of the same category, if this time also suitable candidates in that reserved category could not qualify or found eligible/available.

(ii) If no candidate found eligible/available or could not qualify amongst the differently abled persons for the post then the same shall be filled up from amongst the candidates, other than the differently abled persons i.e. General Category Candidate, as per clause 34 (2) of the Rights of Persons with Disabilities Act, 2016.

#### 2. AGE:-

- Candidate must have attained the age of 35 years and must not have attained the age of 45 years on the last date of submission of application i.e. 31.07.2019.
- For SC/ST/BC candidates of Punjab State, the upper age limit is relaxable by 5 years and for Physically Handicapped (Differently Abled Persons) candidates of Punjab State the upper age limit is relaxable by 10 years.

#### 3. ELIGIBILITY/QUALIFICATION:

A candidate for direct recruitment to the service:

- (a) must be a citizen of India; and
- (b) must have been duly enrolled as an Advocate and must have been in practice for a period not less than seven years as on the last date of submission of applications i.e. 31.07.2019;
- (bb) The applicant shall be an income tax assessee for a period not less than three assessment years (preceding the date of application), with gross professional income of not less than rupees five lakhs per annum. The applicant shall also be required to attach the proof of his independent engagement and conducting of not less than fifty cases (other than bunch cases) for general categories and forty cases for the scheduled caste, Backward Class and physically challenged persons, respectively, per year in the last preceding three years:

Provided that the gross annual income in the case of candidates belonging to the Scheduled Castes, Backward Class and physically challenged persons, shall be rupees three lakhs per annum.

(c) must have passed matriculation examination with Punjabi as one of the compulsory or elective subjects or any other equivalent examination in Punjabi language, specified by the Government from time to time.

#### Note:-

In light of orders dated 10.05.2019, passed by Hon'ble Supreme Court of India in S.L.P. (C) No.14156 of 2015 titled as 'Dheeraj Mor Vs. Hon'ble High Court of Delhi, 'In-service' candidates can not apply for the said posts.

#### 4. DISQUALIFICATION FOR APPOINTMENT:

No person shall be qualified for appointment to the Service or being in Service:

- (i) if he/she has more than one spouse living;
  (Provided that the High Court of Punjab and Haryana, Chandigarh may, if satisfied that there are special grounds for doing so, exempt any person from the operation of this sub-rule).
- (ii) if he/she has been dismissed or removed from service by any High Court, Government or Statutory Body of Local Authority;
- (iii) if he/she was or is convicted for any offence involving moral turpitude or has been permanently debarred or disqualified by any State or Union Government, High Court or Union Public Service Commission or any State Public Service Commission from appearing in any examination or interview;

(iv) if he/she, being an Advocate, was found guilty of professional misconduct under the provisions of Advocate Acts, 1961 (Central Act 25 of 1961) or other law for the time being in force.

#### 5. EXAMINATION FEE:

The Examination Fee for SC/ST/BC/PH (Persons With Disabilities) candidates of Punjab State will be ₹500/- (Rupees Five Hundred only). For General/Other Category candidates it will be ₹1000/- (Rupees One Thousand only). The fee shall be paid by way of Demand Draft in favour of the Registrar General, High Court of Punjab and Haryana, Chandigarh payable at Chandigarh.

#### 6. SYLLABUS AND FORMAT OF EXAMINATION:

- (i) The selection would be on the basis of written test of 750 marks and *viva* voce of 250 marks, to be conducted by the High Court of Punjab and Haryana, Chandigarh.
- (ii) The written test and viva-voce shall be conducted in English medium except the language paper.
- (iii) Syllabus and format of written test will be as per Annexure-2 (page no. 10).
- (iv) Only the candidates securing 40% or more marks in each paper will be called for viva-voce. But merely securing 40% or more marks would not confer any right to be called for viva voce. The High Court of Punjab and Haryana, Chandigarh shall have the discretion to shortlist the candidates equal to three times the number of vacancies for viva-voce. Further, no candidate will be considered to have successfully qualified the Punjab Superior Judicial Service Examination unless he/she obtains 50% marks (read 45% marks for the SC/BC/PH (Differently Abled Persons) category candidates) in the aggregate out of the total marks fixed for the written test and viva-voce. It is also made clear that no candidate will get the right to be appointed even if he/she obtains 50% marks (read 45% marks for the SC/BC/PH (Differently Abled Persons) category candidates) in the aggregate of the written test and viva-voce. However, candidates will be appointed strictly in the order of merit (category wise) in which they are placed after the result of written test and viva-voce.

#### 7. OTHER IMPORTANT INFORMATION:

- 1. 'No Objection Certificate' of the employer (for those candidates who are in government service such as in prosecution department, Advocate General office etc.) is not required at the time of applying. Candidates are directed to only intimate their employer at this stage. No Objection Certificate on the format Annexure-3 (page no. 11) from the Competent Authority will have to be produced at the time of the viva-voce.
- 2. The last date for submission of application forms for the Advocates enrolled with the District/Sub-Divisional Bar Associations of Punjab, Haryana and U.T., Chandigarh is 31.07.2019 till 5:00 PM. All such Advocates will submit the application forms in the office of District and Sessions Judges concerned on or before the last date i.e. 31.07.2019 till 5:00 PM. Ld. District & Sessions Judge must forward the same immediately to the O.S.D.(Recruitment), High Court of Punjab and Haryana, Chandigarh, mentioning the date of receipt of each application.

All others will send/submit the application forms directly to the O.S.D. (Recruitment), High Court of Punjab and Haryana, Chandigarh through Coordination Branch, High Court of Punjab and Haryana, Chandigarh in an envelope superscribed as "Application for the post of Additional District Judge in the State of Punjab" on or before 31.07.2019 till 5:00 PM.

- 3. The reservation and eligibility for SC/ST/BC/PH (Differently Abled Persons) candidates shall be admissible in accordance with the Policy/Rules/Instructions issued by the Government of Punjab from time to time.
- 4. The benefit of reservation is admissible only bonafide domiciles/residents of State of Punjab.
- 5. The candidates belonging to Backward Classes apart from Backward Class certificate are also required to attach a declaration Annexure-4 (page no. 12) that no change occurred in their status and they do not fall in the section of creamy-layer as per Govt. letter No. 10/9/2009-RCI/62 dated 08/1/2010.
- A candidate can claim reservation under the Sports Person category in 6. accordance with the Punjab Recruitment of Sportsman Rules, 1988 which inter alia, provides only if:

He/she belongs to State of Punjab; and

- a) He/she has wor. National Championship in team or individual events while representing the State of Punjab in such sports events as have been conducted by such respective National Federations as are affiliated to the Indian Olympic Association; or
- b) He/she has won National Championship in team or individual events which are organized by the Indian Olympic Association; or
- c) He/she has won first, second or third position in team or individual events and/or he/she has won Gold or Silver or Bronze Medal, at International Sports meets, conducted by International Federations affiliated to the International Olypmic Committee or by the International Olympic Committee itself.
  - If candidate belongs to Sports Person, Punjab Category, an attested copy of Gradation Certificate strictly in accordance with the Punjab Sportsman Rules, 1988 issued by the competent authority should be attached with the application form.
  - Director Sports, Punjab is the competent authority to issue Sports Gradation Certificate and any other Sports Certificate issued by any other authority will not be accepted a valid Certificate for claim of reservation under the Sports Person, Punjab Category.
  - Applicants claiming reservation under Sports Person, Punjab Category must submit Punjab Resident Certificate from the competent authority, failing which would result in cancellation of their candidature.
- Physically Handicapped (Differently Abled Persons), Punjab: The 7. benchmark disabilities as mentioned in the Rights of Persons With Disabilities Act, 2016 for purpose of reservation in employment, are as under:-
  - (a) blindness and low vision;
  - (b) deaf and hard hearing;
  - (c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- (d) autism, intellectual disability, specific learning disability and mental illness;
  - (e) multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts identified for each disabilities:

- 8. The decision of the High Court of Punjab and Haryana, Chandigarh regarding the eligibility of the candidates for admission to the examination shall be final.
- 9. Success in the examination does not confer any right to appointment unless the Government in consultation with the High Court of Punjab and Haryana, Chandigarh is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects for appointment.
- 10. Candidates shall attach the self attested copies of requisite certificates alongwith the Application Form.
- 11. The original certificates along with the self attested copies will also have to be produced at the time of viva-voce.
- 12. Candidates should ensure that they fulfill all the eligibility conditions for admission to the examination. Their admission to the examination will be purely provisional subject to the fulfillment of eligibility criteria of age, educational qualification, nationality etc. as per relevant Rules and Instructions issued by the Government from time to time. If on verification at any stage, it is found that they do not fulfill any of the eligibility conditions, their candidature will be canceled. If any of their claims is found to be incorrect at any stage, they shall also render themselves liable to disciplinary action by the High Court of Punjab and Haryana, Chandigarh.
- 13. No claim that an application form has been lost or delayed in the post office / courier service will be considered nor any representation against its rejection due to late receipt will be entertained.

- 18. The category of reservation and all other information once filled in the application form, shall not be allowed to be changed.
- 19. No travelling expenses or allowances will be payable to any candidate for appearing in written test/viva-voce. However, the Scheduled Caste candidates, if called for written test/viva-voce shall be entitled for travelling allowance, as per relevant instructions of the Punjab Government.
- 20. Any other terms and conditions not specifically mentioned above shall be governed in accordance with the Punjab Superior Judicial Service Rules, 2007 and instructions issued by the Government from time to time.

All the candidates are advised to regularly visit the website in their own interest. - a) Candidates shall read all the instructions printed on the answer-sheet and question paper and instructions incorporated hereunder carefully and comply with the same strictly. Disobedience may lead to disqualification.
- b) No candidate will be admitted to the examination unless he holds a certificate of Admission/Admit Card from the High Court of Punjab and Haryana, Chandigarh.
- No candidate will carry any paper, note-book, writing material, help book having any nexus with the examination. Possession of a mobile phone or any other electronic device in the examination hall is also strictly prohibited.
- d) No candidate will write his roll number at a place other than the one prescribed on the answer-sheet.
- e) Any mark including any religious mark on the answer-sheet, whereby an answer-sheet can be identified to be of a particular candidate, is prohibited. Highlighting/underlining of the answers would also be deemed to be identification marks, which will entail disqualification.
- f) Candidates are required to attempt questions in the same order in which they are in the question paper.
- g) Candidates will not talk to each other during the course of the examination.
- h) No candidate will be permitted to leave the examination room before half time of the examination. Half time of the examination will be indicated with the ringing of a bell.
- The answer-sheet of the candidate using unfair means will be confiscated and such candidate will stand disqualified. In case of copying, the Invigilator will bring the factual position to the notice of the Floor Incharge, and Floor Incharge will bring the matter to the notice of the Block Incharge, whose decision will be final.
- j) Canvassing in any form or at any stage shall be considered a disqualification.
