

**PROCEEDINGS OF THE HIGH COURT FOR THE STATE
OF TELANGANA AT HYDERABAD**

Sub:- Public Services – TJMSS – Notification carving out 32 Judicial Districts in the State of Telangana issued by the Government – Allocation of employees working in the erstwhile District of **Nalgonda** to the newly carved out districts namely **Nalgonda, Suryapet and Yadadri-Bhongir Districts** – Tentative allocation of employees to the new Judicial Districts – **Orders - Issued.**

ORDER ROC.No.864/2022-C.1, DATED: 13-09-2022.

Pursuant to the carving out of 33 Revenue Districts by the State Government, the High Court has decided to carve out 32 Judicial Districts from the erstwhile 9 Judicial districts (except Hyderabad) co-terminus with Revenue districts. Accordingly, necessary orders were issued by the Government and the newly carved out Judicial Districts started functioning w.e.f., 02.06.2022.

Consequent to the carving out of 32 Judicial Districts, the High Court has issued proceedings under reference 2nd read above that the employees under Telangana Judicial Ministerial and Subordinate Services to serve at the places where they were working as on 01.06.2022 till their final allocation.

The Hon'ble the Chief Justice has been pleased to constitute a committee of Hon'ble Judges for framing of guidelines and final allocation of employees of the

Subordinate Courts and recommended the Government for issuance of necessary orders in pursuance of Para 4 of Presidential Order dated: 29.08.2018. Accordingly the government has issued necessary orders.

As per the guidelines (vide reference 4th read above), the members of Telangana Judicial Ministerial and Subordinate Services were directed to submit their options to the erstwhile Unit Head/Principal District Judge concerned for onward transmission to the High Court for their allocation. Accordingly, on considering the options received, the Committee of Hon'ble Judges has allocated the staff members tentatively and directed the Registry to publish the same and to communicate to the employees through the Unit Head concerned.

Accordingly, the list of the employees of erstwhile **Nalgonda** District showing their tentative allocation is hereby published for information and if any of the member of service has got objection for the tentative allocation, he/she shall forward the objection / representation to the High Court through the present Unit Heads on or before **28.09.2022** in a sealed cover. The Unit Heads concerned shall forward the same to the High Court immediately.
