It has come to the notice of the High Court that some of the Judicial Officers have made it a regular habit of leaving the Headquarters during the weekends / Holidays quite frequently, either with or without seeking permission. Absence of the Judicial Officers in their respective stations is causing disruption of work the High Court deprecates such tendency on the part of Judicial Officers.

The Principal District Judges are hereby instructed to oversee and avoid such situation of leaving the Headquarters by Judicial Officers during the weekends / Holidays except in case of emergency and to make themselves available for attending to the Administrative/Judicial/other miscellaneous work attended to during the weekends / Holidays.

All the Unit Heads and the Judicial Officers are therefore directed to strictly follow the instructions contained in the above circulars without fail.
