Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more one in the nature of WRIT OF MANDAMUS declaring the action of the respondents particularly the 2nd respondent in not granting permission to the petitioner to upload the application for attending the counselings for 'B' and 'C' Category NRI quota admission into AYUSH COURSE (Bachelor of Homeopathi Medicine and Surgery (BHMS) and Bachelor of Avurvedi Medicine and Surgery (BAMS)) for the academic Year 2024-2025 is illegal, arbitrary, contrary to the rules and unconstitutional.

ORDER: (Per the Hon'ble the Chief Justice Alok Aradhe)

Mr. P.Akhil Raj, learned counsel represents
Mr. M.Keshav Yadav, learned counsel for the petitioner.

Mr. G.Ravi, learned counsel representing Mr. A.Prabhakar Rao, learned Standing Counsel for Kaloji Narayana Rao University of Health Sciences appears for respondent No.2.

- 2. With the consent of the parties, the matter is heard finally.
- 3. In this writ petition, the petitioner *inter alia* has prayed for the following relief:

"For the reasons stated in the accompanying affidavit, the petitioner herein prays that this Court may be pleased to issue a writ, order or direction, more one in the nature of writ of mandamus declaring the action of the respondents particularly the 2nd respondent in not

granting permission to the petitioner to upload the application for attending the counselings for "B" and "C" category NRI quota admission into AYUSH COURSE (Bachelor of Homeopathi Medicine and Surgery) (BHMS) and Bachelor of Ayurvedic Medicine and Surgery (BAMS) for the academic year 2024-25 as illegal, arbitrary, contrary to the rules and unconstitutional and pass such other order or orders as this Court may deem fit and proper in the circumstances of the case."

4. Learned counsel for the petitioner submits that on account of ill health, the petitioner could not upload her application for counseling in respect of management quota 'B and C' category seats for admission to the AYUSH COURSE (Bachelor of Homeopathi Medicine and Surgery) (BHMS) and Bachelor of Ayurvedic Medicine and Surgery (BAMS) for the academic year 2024-25. It is further submitted that with regard to the grievance of the petitioner, the petitioner has submitted representation dated 26.10.2024. It is also submitted that the aforesaid representation failed to evoke any response and the

writ petition be disposed of with the direction to respondent No.2 to decide the said representation by a speaking order.

- On the other hand, learned Standing Counsel for 5. respondent No.2 submits that suitable action on the aforesaid representation shall be taken by respondent No.2.
- In view of the aforesaid submission and in the peculiar 6. facts of the case, the Writ Petition is disposed of with the direction to respondent No.2- University to decide the representation submitted by the petitioner by a speaking order within three days from today. It is made clear that this Court has not expressed any opinion on the merits of the matter.

Miscellaneous applications, if any pending, shall stand closed. There shall be no order as to costs.
