ORDER: (Per the Hon'ble the Chief Justice Alok Aradhe)

In this writ petition filed as public interest litigation, the grievance of the petitioners pertains to establishment of industrial units manufacturing sponge iron amidst agricultural fields and human habitations. It is the case of the petitioners that the industrial units have been set up without obtaining any permission from the competent authority under the Water (Prevention and Control of Pollution) Act, 1974 (hereinafter referred to as 'the Water Act') and the Air (Prevention and Control of Pollution) Act, 1981 (hereinafter referred to as 'the Air Act'). It has also been pleaded that the official respondents are not taking any

action to prevent the pollution caused by respondent Nos.7 to 23.

- Court, the Telangana Pollution Control Board namely respondent No.3 has filed an additional affidavit. In the additional affidavit, it has been stated that M/s. Jaycee Sponge Profiles Pvt. Ltd. (respondent No.11), M/s. Tirupathi Udyog Ltd. (respondent No.16), M/s. G.K.Soponge Iron Pvt. Ltd. (respondent No.17) and M/s. Sheetal Shipping and Metal Processors Ltd. (respondent No.18), M/s. Binju Metals and Alloys Industries Pvt. Ltd. (respondent No.19), M/s. Harmony Sponge Iron Industry (respondent No.20), M/s. Shivadatrai Ferro Alloys Pvt. Ltd. (respondent No.21), M/s. A.P.S.M.Alloys Pvt. Ltd. (respondent No.22) and M/s. Devashree Ispat (Petitioner) Ltd. (respondent No.23) are non-operational.
 - 4. It is further submitted that the issue with regard to validity of permission granted to other industries namely M/s. Bilasraika Sponge Iron India Pvt. Ltd. (respondent No.7), M/s. Binjusaria Sponge and Power Pvt. Ltd. (respondent No.8), M/s. Anand Metallics and Power Pvt. Ltd.

(respondent No.9), M/s. Sunder Ispath Ltd. (respondent No.10), M/s. Vinayaka Steels Ltd. (respondent No.12), M/s. Reutire Metals of India Ltd. (respondent No.13), M/s. Kedia Alloys Ltd. (respondent No.14) and M/s. Siri Shiv Shakti Steels & Alloys (respondent No.15) was subject matter of challenge before the National Green Tribunal, Chennai Bench. The National Tribunal, Chennai Bench by an order 28.09.2022 dated issued certain directions including submission of action plan for relocation of sponge iron It has also been stated that Telangana State plants. Industrial Infrastructure Corporation has submitted an action plan on 08.12.2020 about the relocation of the sponge iron plants which are situated within a radius of one kilometer from the human habitation namely M/s. Anand Metallics and Power Pvt. Ltd. (respondent No.9), M/s. Sunder Ispath Ltd. (respondent No.10), M/s. Vinayaka Steels Ltd. (respondent No.12), M/s. Kedia Alloys Ltd. (respondent No.14) and M/s. Siri Shiv Shakti Steels & Alloys (respondent No.15).

5. It is pointed out that the remaining industries namely M/s. Bilasraika Sponge Iron India Pvt. Ltd.

(respondent No.7), M/s. Binjusaria Sponge and Power Pvt. Ltd. (respondent No.8), M/s. Reutire Metals of India Ltd. (respondent No.13) are situated beyond a periphery of one kilometer from the human habitation. Learned Additional Advocate General submits that the permission to the industries has been granted under the Water Act and Air Act to run the units.

- 6. Having heard learned counsel for the parties, we deem it appropriate to issue the following directions:
 - (i) The official respondents shall take an action to relocate the industries situated within the periphery of one kilometer from the human habitation within a period of one year from today. A report shall be filed in this regard before the Registrar (Judicial).
 - (ii) The officers of Telangana State Pollution Control Board shall visit the industries and shall find out whether the industries which are in operation are being run in accordance with the provisions of the Environment (Protection) Act, 1986, the Water Act as well as the Air Act. A report in this regard to the

Registrar (Judicial) shall be submitted within a period of two months from today.

- (iii) It shall be open for the State Government to disburse the amount deposited during the pendency of the instant writ petition to such farmers who may have suffered the loss on account of damage to their crops. Needless to state that any such farmers in addition shall be at liberty to take recourse to such remedy as may be available to them in law with regard to damage of their crops which may have occasioned on account of operation of respondent Nos.7 to 23 industries.
- With the aforesaid directions, the Writ Petition is 7. disposed of.

Miscellaneous petitions, pending if any, shall stand closed. There shall be no order as to costs.
