# THE HON'BLE THE CHIEF JUSTICE ALOK ARADHE AND THE HON'BLE SRI JUSTICE J.SREENIVAS RAO

## W.A.NO. 400 OF 2017

JUDGMENT: (Per the Hon'ble Sri Justice J.Sreenivas Rao)

This intra-court appeal is filed aggrieved by the orders dated 17.02.2017 passed by the learned Single Judge in W.P.No.22838 of 2015 rejecting the claim of the appellants.

2. Heard Mrs.Latha Alapati, learned counsel for the appellants, Mr.Mohammed Imran Khan, learned Additional Advocate General appearing on behalf of respondent Nos.1 to 6 and Mr.S.Chakrapani, learned counsel appearing on behalf of respondent No.7.

3. During the course of hearing, learned counsel for the appellants submitted that pursuant to the interim order granted by the Division Bench of this Court in W.A.M.P.No.845 of 2017 dated 06.04.2017, the respondent authorities have allotted 2 BHK Flats to the 24 appellants, out of 50 appellants. The remaining 26 appellants are also entitled under Jawaharlal Nehru National Urban Renewal Mission (JNNURM) scheme. However, the respondent authorities are not considering the claim of those 26 appellants without any reasons.

4. Learned Additional Advocate General appearing on behalf of respondent Nos.1 to 6 submitted that the respondent authorities have provided 2 BHK Flats under JNNURM scheme basing on their eligibility. The remaining 26 appellants have not approached the respondent authorities and not submitted applications. If the said appellants submitted applications, the respondent authorities will consider the same, in accordance with law, and requested the Court to grant reasonable time.

5. Learned counsel for the appellants by way of reply submitted that the remaining 26 appellants may be granted liberty to submit applications afresh and the respondent authorities may be directed to consider the same on par with other appellants, who were granted 2 BHK Flats under JNNURM scheme.

6. In view of the above said submissions made by the respective parties, the 26 appellants are granted liberty to submit applications for allotment of 2 BHK Flats under JNNURM Scheme within a period of four (04) weeks from the date of receipt of a copy of this judgment. On such applications, respondent Nos.1 to 6 are directed to consider the same and pass appropriate orders, in accordance with law, within a period of two (02) months from thereafter. It is needless to observe that this Court is not expressed any opinion on merits.
