WRIT APPEAL Nos. 1300 and 1301 of 2024

COMMON JUDGMENT: (Per the Hon'ble the Chief Justice Alok Aradhe)

Mr. M.Pratheek Reddy, learned counsel for the appellants.

Mr. N.Sreedhar Reddy, learned counsel for the respondents No.1 to 238 in W.A.No.1300 of 2024 and for the respondents No.1 to 11 in W.A.No.1301 of 2024.

Ms. B.Mohana Reddy, learned Government Pleader for Agriculture and Cooperation Department for the respondents No.239 to 243 in W.A.No.1300 of 2024 and for the respondents No.12 to 16 in W.A.No.1301 of 2024.

2. With the consent of the learned counsel for the parties, the appeals are heard finally.

3. These intra court appeals are directed against the common order dated 15.07.2024 passed by the learned Single Judge in W.P.Nos.21672 and 35012 of 2022.



4. Facts giving rise to filing of these appeals, in a nutshell, are that the Managing Committee of Journalists' Co-operative Housing Society Limited (hereinafter referred to as, "the Society") prepared a voters list on 29.06.2020 and requested its members to verify the same and to file objections to the voters list on or before 31.07.2020. According to the respondents No.1 to 238 in W.A.No.1300 of 2024 and the respondents No.1 to 11 in W.A.No.1301 of 2024 (hereinafter referred to as, "the writ petitioners"), no objections were preferred to the aforesaid list. Thereupon, the President of the Society sent a communication dated 04.08.2020 to the Divisional Cooperative Officer, Golconda Division, requesting him to conduct elections on the basis of the voters list.

5. According to the writ petitioners, on 31.08.2020, the President of the Society forwarded a list of 340 new members, who were admitted in the month of February, 2020, to consider their case for voting, as the elections were postponed on account of COVID-19 pandemic. The Deputy Registrar of Cooperative Societies issued a notice

on 23.09.2020 by which the objections were invited from the members and the final voters list was displayed. One M.S.H.Hashmi filed a writ petition, namely W.P.No.99 of 2021. A learned Single Judge of this Court, by an order dated 24.03.2021 directed the District Cooperative Officer, Hyderabad, to conduct elections within a period of three However, despite the direction issued by the months. learned Single Judge of this Court, the elections were not held. The writ petitioners thereupon filed a writ petition, namely W.P.No.21672 of 2022, in which the action on the part of the Society in not conducting the elections as per the directions of the Court dated 24.03.2021 in W.P.No.99 of 2021 was assailed. The writ petitioners further sought a direction that the names of the writ petitioners as well as all eligible members who are entitled to vote be included in the voters list. The learned Single Judge, by an interim order dated 28.04.2022, granted the liberty to the writ petitioners to make a detailed representation for continuing their names in the list of members of the Society and on making such representation the authorities were directed to consider the same within a period of three weeks from

the date of making such representation and in any case before issuance of election notification for conducting elections to the Society. When the representation submitted by the writ petitioners was rejected, W.P.No.35012 of 2022 was filed.

6. The learned Single Judge, by the common order dated 15.07.2024, directed the State Cooperative Election Authority to verify the records of the Society and finalise the voters list with the assistance of the Deputy Registrar of Cooperative Societies, Golconda Division, Hyderabad, without being influenced by the report submitted by the Three Member Committee and to initiate the process of election within a period of four months. Hence, these appeals.

7. Learned counsel for the appellants submitted that the learned Single Judge ought to have appreciated that the writ petitioners nowhere had assailed the validity of the report submitted by the Three Member Committee and therefore, the learned Single Judge ought not to have issued a direction for preparation of the voters list without

being influenced by the report submitted by the Three Member Committee.

5

8. On the other hand, learned counsel for the writ petitioners submits that the names of the writ petitioners are already included in the voters list. It is also pointed out that the objections to the proposed voters list have been invited and the members whose names have not been included in the list may be granted the liberty to submit the objections.

9. We have considered the rival submissions made on both sides and have perused the record.

10. From the prayer made in the writ petitions, it is evident that the specific challenge to the report submitted by the Three Member Committee has not been made. However, it is not in dispute that despite the directions issued by this Court dated 24.03.2021 in W.P.No.99 of 2021, the elections to the Managing Committee of the Society have not been held. The final voters list has already been published by including the names of the writ



petitioners. Therefore, it is directed that the State Cooperative Election Authority shall proceed to conduct the elections of the Society within a period of two months from today.

To the aforesaid extent, the common order passed by 11. the learned Single Judge dated 15.07.2024 is modified.

Accordingly, the appeals are disposed of. 12.

Miscellaneous applications pending, if any, shall

stand closed. However, there shall be no order as to costs.

DISPOSING OF BOTH THE WRIT APPEALS WITHOUT COSTS
