- 2. This petition has been filed for non-compliance of the order dated 30.10.2024 passed by this Court in W.A.No.1246 of 2024.
- 3. Learned Special Government Pleader for the respondent submits that in compliance of the directions contained in the aforesaid order, the encroachment on the land in question has been removed by the authorities on 13.12.2024. It is submitted that the application seeking

the benefit of the housing scheme filed by the petitioners shall be decided within a period of three weeks from today.

- 5. We do not find any ground to proceed further with the contempt petition. Accordingly, the same is disposed of.
