Mr. P.S. Rajasekhar, learned Standing Counsel for Telangana State Public Service Commission (for short, "the Commission") appears for respondent No.2.

2. I.A.No.1 of 2026 is filed for condonation of delay of 11 days in filing the instant appeal.

3. The appellants were the writ petitioners in W.P.No.12819 of 2025 and unofficial respondents in W.A.No.1079 of 2025. W.A.No.1079 of 2025 together with other appeals were heard at length by this Court and judgment has been reserved on 30.12.2025. The present appellants were also represented in W.A.No.1079 of 2025. Now, in the present appeal, they seek to question the impugned judgment whereby the learned writ Court has allowed the following reliefs in favour of the writ petitioners:

"372. In view of the foregoing discussions and also taking into consideration the facts and circumstances mentioned above, these writ petitions are disposed of with the following directions:-

(a) The Final Marks List dated 10.03.2025 as well as General Ranking List (GRL) dated 30.03.2025 are hereby set aside.

(b) The respondent authorities are directed to re-evaluate all the answer scripts of the Group-1 mains examination by applying the moderation method in terms of *Sanjay Singh and Anr. Vs. U.P. Public*

Service Commission, Allahabad (2007 (3) SCC 720), manually and announce the results. Based upon such results, the respondents authorities are directed to take steps for filling up of said 563 posts.

(OTHERWISE)

(c) This Court is inclined to cancel the Group-I Mains examination. The respondent authorities are directed to re-conduct the Group-I Mains examination in Notification No.02/2024 dated 19.02.2024, for those who have succeeded in the prelims examination.

d) The above said exercise should be completed within a period of eight (08) months from the date of receipt of a copy of this common order.”

3. Learned Senior Counsel for the appellants fairly concedes that the appellants were the unofficial respondents in W.A.No.1079 of 2025 which has been heard at length and orders have been reserved.

4. Learned Standing Counsel for the Commission has strongly opposed the maintainability of this appeal as the present appellants were party in W.A.No.1079 of 2025 which has been heard at length along with other writ appeals and judgment has been reserved by this Court. Now, a party, who has already participated in a proceeding and in which judgment has been reserved, should not be allowed to again raise up the issue by filing the

present appeal. Therefore, the appeal may be dismissed. Even otherwise also it suffers from delay.

5. We have taken note of the facts and circumstances above. The appellants herein were party in W.A.No.1079 of 2025, which has been heard at length by this Court along with other appeals against the same impugned judgment and were reserved for pronouncement of judgment. In such circumstances, the approach of the appellants in filing this appeal cannot be encouraged.

6. Therefore, I.A.No.1 of 2026 and the writ appeal are dismissed. No order as to costs.

Miscellaneous applications pending, if any, shall stand closed.

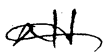

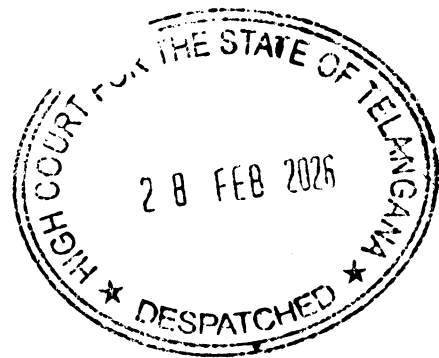
