Mr. B.Aravind Reddy, learned counsel appears for the applicant.

This Court, by order dated 21.11.2025, has appointed Mr. C.Venkatesh, a former District Judge, as an independent arbitrator to adjudicate the dispute between the parties.

However, the proposed Arbitrator has conveyed his inability to accept the appointment as Arbitrator on his reemployment as Deputy Director (Legal) in the institution of Lokayukta.

Therefore, I propose to appoint Mr. V.Niranjan Rao, retired District Judge (presently residing at Villa No.6, MYP1 Green Castle, Gundla Pochampally Village, Medhal-Malkajgiri District, Hyderabad) as an independent Arbitrator to adjudicate the dispute between the parties. The proposed Arbitrator is requested to submit his consent and a declaration in terms of Section 12(1) read with Schedule VI of the Arbitration and Conciliation Act, 1996.

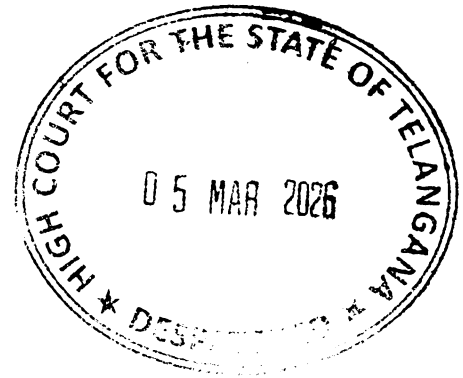
