

HIGH COURT FOR THE STATE OF TELANGANA :: HYDERABAD

**NOTIFICATION
IN
R.O.C.NO.441/2017-RC**

This is to inform that the learned Principal District Judge, Khammam, issued Notification Nos.2/2017, 3/2017, 4/2017 and 5/2017, dated 03-01-2017 for direct recruitment to six(06) posts of Junior Assistant, three (03) posts of Process Server, two (02) posts of Field Assistant and one (01) post of Examiner respectively; that in the meanwhile, the High Court called for vacancies from all the Judicial Districts of Telangana to issue Notifications under centralized and online direct recruitment to the posts under Telangana Judicial Ministerial and Subordinate Services. The learned Principal District Judge, Khammam, forwarded the sanctioned strength and vacancy position in all the categories under direct recruitment vide letters dated 08-04-2019, 26-04-2019 and 19-07-2019. Accordingly, the High Court issued Notification Nos.1/2019 to 9/2019, dated 31-07-2019 inviting applications through online for direct recruitment to the posts in the Judicial Districts of Telangana.

The learned Principal District Judge, Khammam, vide letter in Dis.No.199, dated 18-01-2021, stated that the vacancies notified in the recruitment notifications issued by the District Judge, Khammam, vide Notification Nos.2/2017, 3/2017, 4/2017 and 5/2017, dated 03-01-2017 for direct recruitment to six(06) posts of Junior Assistant, three (03) posts of Process Server, two (02) posts of Field Assistant and one (01) post of Examiner respectively, are included in the subsequent Notifications issued by the Hon'ble High Court vide Notification Nos.2/2019, 4/2019, 5/2019 and 8/2019, dated 31-07-2019 for direct recruitment to 49 posts of Junior Assistant, 11 posts of Field Assistant, 10 posts of Examiner and 24 posts of Process Server in the Unit of Khammam District Judiciary.

The High Court on considering the letter of the Principal District Judge, Khammam, stating that the vacancies were included in the subsequent Notifications issued by the High Court, cancelled the recruitment Notifications issued by the District Judge, Khammam, vide Notification Nos.2/2017, 3/2017, 4/2017 and 5/2017, dated 03-01-2017 for direct recruitment to six(06) posts of Junior Assistant, three (03) posts of Process Server, two (02) posts of Field Assistant and one (01) post of Examiner respectively.
