It is to inform that, the High Court, vide its notification under reference 1<sup>st</sup> cited, rejected the candidature of certain applicants for the reasons stated therein, in connection with the recruitment to 94 posts of Civil Judge (Junior Division) notified on 01-12-2025.

It is further informed that, the representation submitted by the candidate "Sri Pottala Srinivas" (Appl.No.202500569), whose candidature was rejected, vide Annexure - VII as per the notification under reference 1<sup>st</sup> cited, enclosing a copy of Government Gazette with regard to the publication of change of his name as "**Pottala Rudra Thej**", is considered and he **is provisionally permitted to appear for the said computer based screening test.**

But, **the applicants shown in "Annexure-F" (appended to this notification) have not submitted the required certificate, and hence they will be provisionally permitted to participate in the Recruitment process under Open Competition category.**

Further, **the candidature of applicants shown in "Annexure -G" are rejected**, as they have not fulfilled the eligibility criteria specified for Open Competition category, i.e., "crossed the maximum age limit of 35 years specified for Open Competition candidates".
