Sub: High Court for the State of Telangana – Stipulation of Dress code to the Judicial Officers in the State – Instructions issued – Reg.

The dress code of the Judicial Officers should be in keeping with the dignity of their office, shorts and shits-sleeves, multicolored sarees, jeans etc. are quite unsuitable for the Presiding Officers of a Court. Therefore, the High Court is pleased to prescribe the following dress code for all the Judicial Officers in the State with immediate effect:

Dress of gentlemen Judicial Officers:

The gentlemen Judicial Officers in the State should wear full suit with white full shirt, grey or white trousers, black coat, tie and Black/brown shoes.

Dress of lady Judicial Officers:

All lady judicial officers should wear:

- (a) White/black, full/half sleeved, high neck blouse/shirt with collar
- (b) Sarees white/cream/grey/black (or) combination thereof
- (c) Salwar/Churidar/Long Skirt/trousers (white/cream/grey/black)
- (d) Full Sleeved black coat/other Full Sleeved coat

Note: Nothing should be worn which is likely to cause disturbance during the court proceedings or which is unbefitting to the dignity of a Judicial Officer.

All the Judicial Officers shall wear over, a black-coloured coat, a Judge's gown, white collar stiff/soft and white bands, while presiding over the Court.

On ceremonial occasions and official functions/visits, (i) the gentlemen Judicial Officers shall wear full suit, sobre colour shirt with full sleeves, tie and shoes, (ii) the lady Judicial Officers shall wear dress as indicated in (a) to (c) above with full sleeved coat befitting the dignity of a Judicial Officer.

Therefore, all the Presiding Officers in the State are hereby directed to follow the above dress code scrupulously.

All the Unit Heads in the State are requested to circulate the instructions among all the Judicial Officers in the Unit for compliance and monitor the implementation.
