It is brought to the notice of the High Court by the Chairman, Bar Council of State of Telangana vide letter reference 1st cited, that Hon'ble High Court issued Circular instructions making it mandatory for filing Petitions, Affidavits, Counters, Memorandum of Appeals and other proceedings/ Documents in the High Court for the State of Telangana in A4 size paper printed on both sides with effect from 01.01.2022 and requested to the High Court to issue suitable circular instructions to all the Unit Heads in the State to make applicable the directions given in the said circular to all the Subordinate Courts in the State, so as to maintain uniformity in all Courts in the State of Telangana.

The High Court having considered the same hereby directs that all Suits, Petitions, Applications, Affidavits, Counters, Memorandum of Appeals and other proceedings/Documents, etc., to be filed in the Subordinate Courts in the State of Telangana shall be in **A4 size paper** printed on both sides of the paper.

Therefore, as directed, all the Unit Heads in the State are instructed to see that above instructions are complied with including issue of certified copies of the documents in A4 size papers and Unit Heads are further directed to circulate a copy of the circular to all the Judicial Officers/Courts in your unit to follow the instructions scrupulously.

The Circular instructions shall come into force with effect from **01.01.2022.**
