## ORDER ROC.No.1409/2016-VIGILANCE CELL, DT.04-07-2016

The High Court issued orders vide proceedings, 3<sup>rd</sup> read, placing Sri V.Vara Prasad, former XIV Additional District Judge, Rangareddy, under suspension with a direction to remain at L.B.Nagar, Rangareddy and during the period of suspension he shall not leave the headquarters without obtaining prior permission of the High Court.
